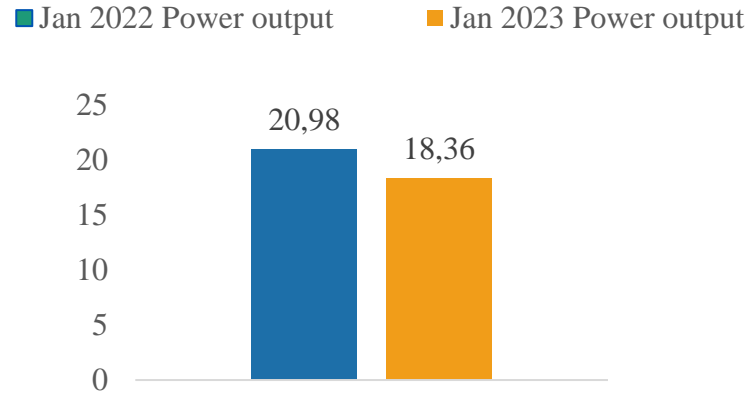

Status of electricity generation

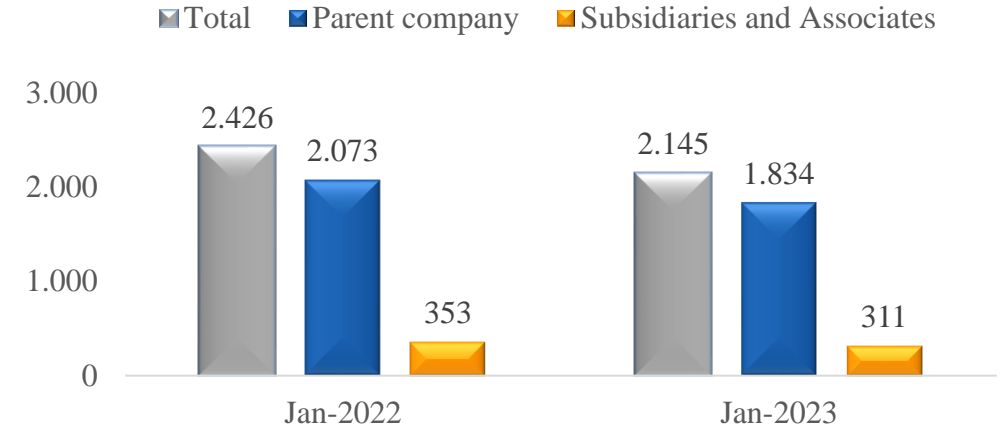
Electricity output of the entire system

ENTIRE POWER SYSTEM

- ❖ Electricity output of the entire system in January 2023 reached **18.36 billion kWh**, decreased 12.5% over the same period in 2022 due to low load during the New Year's Day and Year of The Cat Holidays of 2023.
- ❖ Hoa Binh, Thac Ba and Tuyen Quang hydropower plants are fully operated to supplement water sources, ensuring production of the Winter-Spring crop. Thermal power plants mobilize according to system demand.
- ❖ The entire system has ensured safe and continuous power supply, serving socio-economic development, meeting people's daily needs, especially ensuring safe and stable electricity supply during the Year of The Cat Holidays of 2023.

EVNGENCO3

- ❖ Electricity output in January 2023 of EVNGENCO3 reached **2,145 million kWh**, equaling 88.43% compared to the same period in 2022.
- ❖ Hydropower plants continue to reasonably and effectively regulate reservoirs to make the most of water sources for electricity production and ensure operation according to the inter-reservoir process.
- ❖ Thermal power plants mobilize according to system demand.



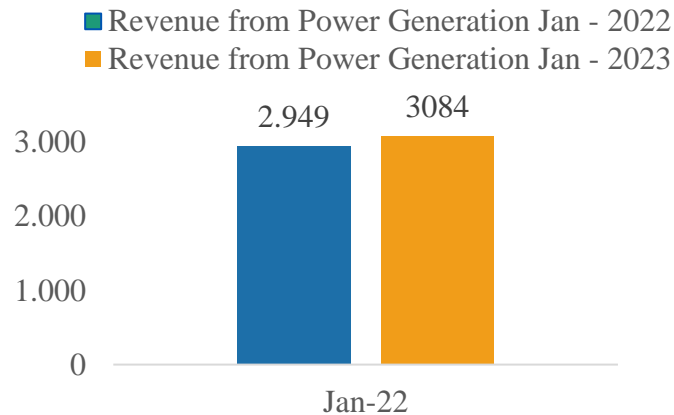

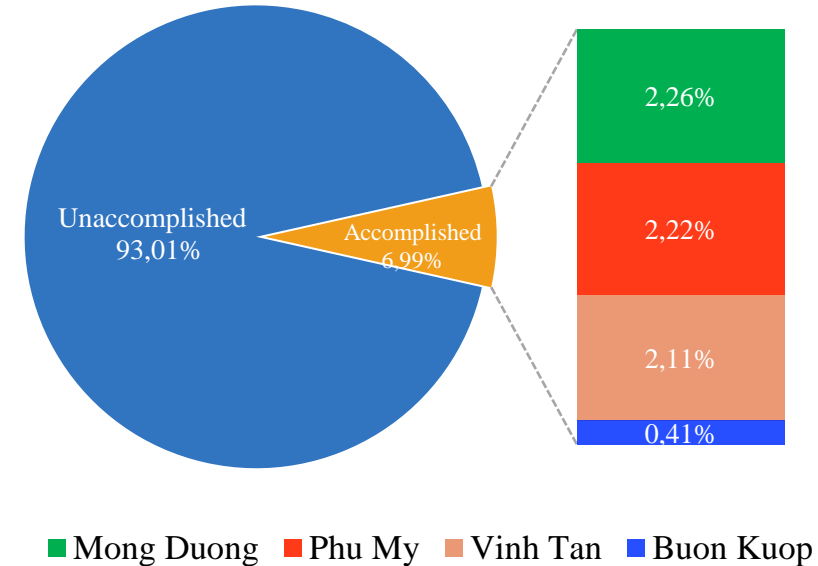

EVNGENCO3 Parent company (billion VND)



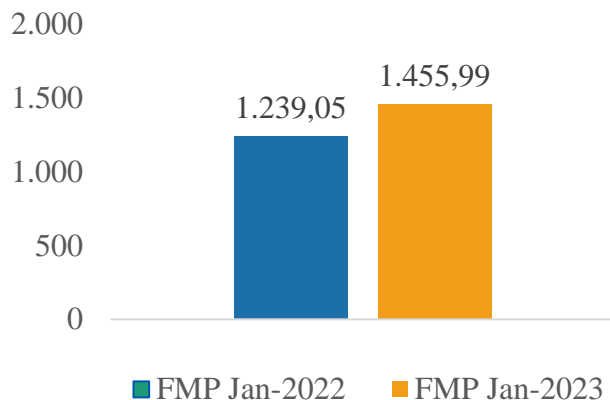

Power generation revenue in January 2023 of parent company EVNGENCO3 was estimated at **3,084 VND**, an increase of 4.58% over the same period in 2022. In which, Mong Duong Thermal Power Company accounted for the highest proportion (2.26%) of the total. revenue from power generation, followed by Phu My Thermal Power Company (2.22%), Vinh Tan Thermal Power Company (2.11%) and Buon Kuop Hydropower Company (0.41%).

THE POWER MARKET

- ✧ Average full market price (FMP) in Jan-2023: **1,455.99 VND/kWh**, 17.51% higher than the same period in 2022

GAS SUPPLY CAPABILITY

- ✧ The average gas supply capacity in the Southeast region in January 2023 is about: **13.6 million m³/day**, ensuring electricity production.

GAS CONSUMPTION AT PHU MY POWER PLANTS

- ✧ Lowest gas consumption: **0.9 million m³/day**
- ✧ Average gas consumption: **3.5 million m³/day**
- ✧ Highest gas consumption: **6.2 million m³/day**
- ✧ The plants ensure fuel gas, oil always maintain optimal inventory for production.

COAL FUEL SITUATION

- ✧ Coal supply for thermal power plants ensures production.

VINH TAN 2 OIL PORT UPGRADING PROJECT

- Increase the capacity to receive ships from 1,000 DWT up to 3,000 DWT.
- Serving the slag export of ash, improving efficiency and reducing transportation costs.
- Progress: On January 13, 2023, the Vietnam Maritime Administration issued Decision No. 31/QĐ-CHHVN officially announcing the upgraded oil port to receive ships up to 3,000 DWT.



SMALL WIND AND HYDROPOWER PROJECTS

- Progress: Research, promote and cooperate in developing potential small hydro and wind power projects to be deployed when the Government approves the Power Master Plan VIII.



VINH TAN 2 COAL PORT UPGRADING PROJECT

- Increase the capacity to receive ships from 30,000 DWT up to 50,000 DWT.
- The project helps to improve the efficiency of coal supply for the plant in the near future
- Progress: Basically completed the construction, continuing to dredging the water area in front of the wharf according to the schedule.
