


7 MONTHS' RESULT & KEY HIGHLIGTHS



- Production volume in the 7 months reached **20,078 mn kWh**, equivalent to **55.27%** of that planned for 2018. Phu My Thermal Power Plant, Vinh Tan 2, Mong Duong 1 are operating stably and Buon Kuop Hydro Power Plant is highly mobilized regarding the level of waterflow (about **8.02** million kWh / day)
- Completed the overhaul of the GT25 PM2.1MR unit and hand over to A0 to operate at 23:33 'on 18/8/2018.
- Estimated revenue in 7 months of 2018 is 23,228 billion, reaching 56.12% of the 2018 plan.
- In the first seven months of 2018, profit before tax from electricity production was around VND **1,327 billion**, reaching **97.52%** of the 2018 plan.
- The environmental protection in power plants in general and the Vinh Tan 2, Mong Duong 1 and Ninh Binh thermal power plants in particular have always been ensured.





MISSIONS OF EVNGENCO 3 IN AUGUST/2018

EVNGENCO 3 anticipates production volume in August reach 3.127 billion kWh in which the independent companies: 2,874 billion kWh ; Joint-stock companies: 253 billion kWh .
In August/2018, the Corporation accelerated the overhaul of the GT22-PM2.1 unit and focused on stabilizing the production of Phu My, Vinh Tan 2, Mong Duong 1, Ba Ria and Ninh Binh met the request of A0.
Buon Kuop Hydropower Project will be highly exploited according to the plan and the level of water flow.
Ensuring the environment of all EVNGENCO 3's power plants.
Vinh Tan 2 Solar Project: implement compensation and site clearance and selection of contractors for EPC bidding packages, signing and performance of contract packages.
